



This solution provides users with the ability to remove confidential information from documents and visually identify, create, update and maintain the automated flow of FOIA request processing and correspondence tracking.

VeriDact Correspondence Tracking & eFOIA Suite provides:


- A secure BPM engine that is highly flexible and customizable
- Enables internal and external reviewers to customize the stages of review for a document
- An easy-to-use graphical interface tool for business processes development, which can be serial, parallel or can change mid-stream based on the users parameters



- Automatic routing of process stages once certain criteria in the approval process has been met
- Automatic notification and initiation of business process steps
- Security classification tools
- Capture, separate, and index documents
Eliminate printing costs and reduce batch preparation time. Index data can be automatically extracted from every document or page based on an indexing rule set built in to the software
- Classify documents by content
Sort documents and redact the pre-defined words, phrases or concepts based on the redaction rule set
- Automatically or manually search text
Search for a word or phrase
- Redact words, Regular Expressions, sentences, sections or whole pages of a document
Identify words, phrases and concepts for redaction based on a pre-defined rule set using interface below:



- Assign general exemption codes or customize your own
Redaction exemption codes or other annotations can be pre-defined by a rule set or can be customized



- Provides analyst review and approval for each redaction
Draft version of the document is sent to a review / analyst station for redaction validation and verification. See figure above for sample pre-redacted highlighting.
- Create an audit trail for legal purposes
Save the original and redacted version in multiple formats
